#### 3.3 Law infringement penalties



The **old RGPD**: three large groups of sanctions depending on the level of the infringement.

Minor infringement: "Collect personal information without providing information to the

From 601,01€ to 60.101,00€.

#### Serious infringement:

affected".

"Communicate or transfer personal data without consent".

The **current RGPD**: different and wider criteria according with particular cases.

#### **New sanctions**

- Up to 10 million euros
- Up to 20 million euros



## 3.4 Personal Data Protection Organic Law



Ley Orgánica de Protección de Datos (LOPD)

## 3.5 Approved changes about data protection



The approved changes affect companies, in general terms, as follows:

→ Companies are required to have a Data Protection Delegate.

→ No need to register the files in the Spanish Agency for Data Protection (AEPD)

→ Increase penalties.

#### Be careful what you post

Even when we delete a photo or opinion the servers keep them. In addition, someone could have shared it or have copied before.

## Take care with your privacy

#### Act in front of stalkers

Cyberbullying? Three rules:

- Ignore and block the cyberbullies.
- Keep all the evidences, as screenshots, or don't erase the messages.

- Report the situation to the same social network and, of course, to the police.





The online payment and invoice.



**Robinson list**: web where consumers can register.




Companies: legal obligation to consult the Robinson List



#### 7.2 Tips for citizens







Less publicity: When you sign up, only the companies to which you have given your consent can send you advertising.



**Easy to use:** You just have to register and indicate by what means you do not want to receive advertising: telephone, postal mail, email or SMS.



**Revoke your consent:** You may revoke the consent for commercial calls from companies to which you have given your consent.




